**Shielding and Radiation Protection Review Effort and Licensing Conditions for Dry Storage Applications: Draft Interim Staff Guidance; Withdrawal; 10 CFR Part 72 (NRC-2013-0051)**

On March 7, 2014, the NRC published a document in the *Federal Register* ([79 FR 13002](#)) announcing the withdrawal of draft Spent Fuel Storage and Transportation Interim Staff Guidance No. 26A, Revision 0, "Shielding and Radiation Protection Review Effort and Licensing Parameters for 10 CFR [Title 10 of the *Code of Federal Regulations*] Part 72 Applications." The withdrawal was effective on March 7, 2014.

**Technical Assistant Activities Related to New Reactor License Applications (US-APWR)**

On March 7, 2014, as a result of non-competitive solicitation, an indefinite delivery/indefinite quantity, cost plus fixed-fee contract and task order 01 (NRC-H-25-14-C-0001/NRC-HQ-25-14-T-0001) was awarded to Information System Laboratories, Inc. of Rockville, MD. This contract and order will support the technical and scientific disciplines accomplishing work related to activities aimed at ensuring the overall safety, security, and adequacy of nuclear power plant design, construction, and operations. The period of performance is March 7, 2014 to March 6, 2016. The total estimated ceiling cost for the base award is \$7,269,463 and the total price for task order 01 is \$97,106.

**List of Approved Spent Fuel Storage Casks: Transnuclear, Inc. Standardized NUHOMS® Cask System: Direct Final Rule; 10 CFR Part 72 (RIN 3150-AJ28; NRC-2013-0236)**

On March 10, 2014, the NRC published a direct final rule in the *Federal Register* ([79 FR 13192](#)) amending its spent fuel storage regulations by revising the Transnuclear, Inc. Standardized NUHOMS® Cask System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 13 to Certificate of Compliance No. 1004. The final rule will be effective on May 24, 2014, unless significant adverse comments are received on the companion proposed rule ([79 FR 13260](#)) by April 9, 2014.
