Approval of American Society of Mechanical Engineers' (ASME) Code Cases; Technical Corrections; Final Rule; 10 Code of Federal Regulations Part 50 (Regulation Identifier Number 3150-AI72; NRC-2009-0359)

On December 11, 2014, the NRC published a document in the *Federal Register* ([79 FR 73461](#)) amending its regulations to make technical corrections, including adding three inadvertently omitted addendums to Section XI, "Rules for Inservice Inspection of Nuclear Reactor Coolant Systems," of the ASME Boiler and Pressure Vessel Code to the list of documents approved for incorporation by reference; and correcting a footnote number. This rule was effective on December 11, 2014.

Generic Safety Issue (GSI)-191 Public Meeting with South Texas Project

On December 1-3, 2014, the staff conducted a 3-day public meeting with the South Texas Project (STP) to discuss technical issues related to GSI-191 and their current license amendment request (LAR) for a risk-informed response to Generic Letter 2004-02 "Potential Impact Of Debris Blockage on Emergency Recirculation During Design Basis Accidents at Pressurized-Water Reactors". Issues discussed included: calculations and testing to determine head loss, impact of coating debris and chemical effects, appropriate use of probabilistic risk assessment, and other issues specific to a pending second round of requests for additional information. The meetings included representatives from STP, their contractors, and other licensees anticipating similar LARs. Additional meetings are being scheduled for the first quarter of 2015 as STP develops responses to the staffs requests for additional information responses.

Consultancy Meeting at International Atomic Energy Agency (IAEA)

On December 1-5, 2014, the staff participated in the IAEA Second Consultancy Meeting in Vienna, Austria. The purpose of the meeting was to develop a TECDOC (technical report) on equipment qualifications for severe accident conditions. The purpose of the report is to address qualification methodology and unique considerations of severe accidents for electrical and instrumentation and control equipment dedicated to mitigate or monitor the progress of a severe accident. In addition, the report will provide current and best international practices on equipment qualifications. A final meeting is planned for Summer 2015, and completion of the report is expected by the end of calendar year 2015.
